Representative Cases

- Defended drywall supplier in the first contested Chinese Drywall jury trial in the United States, and the Firm was involved in the first Chinese Drywall class action lawsuit; WWHGD represented the target Defendant for the South Florida claims in the class action which involves over 100 Defendants and 2,000 homeowner Plaintiffs in half a dozen states; Litigation still continues in several state courts and in Multi-District Litigation where the Firm is on the Defense Steering Committee.
- Received a defense verdict in a wrongful death case brought by the estate of a heavy equipment operator who was crushed to death when the paving machine he was operating rolled down an embankment. The decedent left a wife and seven children. Plaintiff's last demand during trial was \$17 million.
- Represented a transportation company and driver after a tragic collision involving a tractor-trailer, car and school bus, resulting in the deaths of several minors. The case involved more than 15 separate personal injury suits.

- Defended and obtained a favorable settlement on behalf of a Palm Beach County company and employee involved in a motor vehicle accident in which the Plaintiff suffered permanent brain damage.
- Represented a large hotel in Broward County in a parasailing accident which resulted in one death and serious permanent injuries to another due to a broken tow line. The high-profile case was settled.
- Obtained verdict on behalf of a sub-contractor in claim for construction fees after a 5 day trial in Jacksonville. Jury awarded full amount of claimed damages, resulting in complete recovery, including attorneys fees and costs. Also prevailed on counterclaim by the defense for alleged project abandonment.
- Obtained a defense verdict in a medical malpractice trial where the plaintiff claimed the neonatologist did not treat micro-seizures in a newborn, allegedly resulting in brain damage. The economic damage claim exceeded \$11 million.
- Represented a large hotel company in an alleged carbon monoxide poisoning which killed one hotel guest and injured seven others in Key West. The cases were confidentially settled.
